

A scheme of financial assistance to persons with special needs is being implemented by our Department. Scheme aims to-

1. Facilitate the care of children with special needs, acknowledging the high cost of care giving.
2. Facilitate education, training and employability of persons with disability, so that they may fulfill their role and potential in society and lead a life of dignity.
3. Help ensure survival of the person with special needs and their family.

Under the scheme, financial assistance of Rs. 2500/- per month is credited to the bank accounts of such persons residing in Delhi. The scheme is available to all persons fulfilling the following eligibility criteria-

- a) Age between 0-59 years
- b) Disability at least 40% and above and have a disability certificate issued from a govt. hospital
- c) Resident of Delhi for at least 5 years prior to application
- d) Family income not more than Rs 1.00 lakh per annum
- e) Having an Aadhaar number
- f) Having a single-operation bank a/c. This provision may be relaxed for minors or those not able to operate a single a/c. The a/c also needs to be linked with the Aadhaar number of the applicant.

I request you to take necessary action for wide publicity of the scheme in all departments under your jurisdiction including all schools and special schools so that the outreach of the scheme is expanded. Applications can be made online on edistrict.delhigovt.nic.in portal. Alternatively, the form can be downloaded from our website and submitted in the district offices.
