The application are invited from the (i) EWS students and (ii) Other than EWS category students admitted in 2021-22 Batch from each program and branch, of B.Tech./DMAM/B.Arch. with Highest CGPA in First Year, for the grant of 100% Tuition Fee Waiver.

(i) For EWS Category-

- The student with Highest CGPA on the basis of result of first year from each program and branch of B.Tech./DMAM/B.Arch. and having no back paper, is eligible for the 100% Tuition Fee waiver.
- The students who have taken admission in EWS category in 2021 batch are only eligible to apply.
- The EWS students will have to submit a valid EWS certificate issued by the Competent Authority.

(ii) For Other than EWS Categories-

- The student with Highest CGPA on the basis of result of first year from each program and branch of B.Tech./DMAM/B.Arch. and having no back paper, is eligible for the 100% Tuition Fee waiver.
- All students who have taken admission in category other than EWS in 2021 batch are eligible to apply.

(iii) General Information-

- In case the Highest CGPA in any branch is from EWS category student, she will be considered for Tuition Fee waiver in EWS category. Then the student with next Highest CGPA will be considered for Tuition Fee waiver for Other than EWS category.
- In case of tie between two or more students the following procedure shall be applied to decide the topper of program:
 - In case of tie in CGPA score, total marks obtained in previous year (Both Semester) will be the topper
 - In case tie is not resolved by a), then the student with highest marks in theory papers will be the topper.
 - In case tie is not resolved by b), then the student with highest marks in elective papers will be the topper.
- The claimant should have 75% attendance in each year.
- Student should not indulge in any misconduct or unfair means in exams.
- The eligible student will not be availing any other scholarship from any other source for the same period.

The application in the prescribed format as given below, duly recommended by the concerned HoD, along with supporting documents as mentioned therein is to be submitted in the office of Academic Branch by **03/01/2023 upto 4:00 pm.**
