## ORDER

All the above faculty members can exercise their options in the prescribed form enclosed herewith as "Annexure-A" for pay fixation on grant of financial up-gradation/promotion under CAS, whether the pay is to be fixed from the date of grant of financial up-gradation/promotion or after earning next increment in the lower grade, within one month from date of issue of orders failing which the pay will be fixed from the date of eligibility. The option once exercised shall be final.

Besides, all the above faculty members will be required to furnish undertaking, as per Annexure-"B", regarding recovery of over payment due to this financial up-gradation or pay fixation thereafter detected in the light of discrepancies noticed subsequently will be refunded by me to the University either by adjustment against future payments due to me or otherwise.

The other contents of the Order No. F.3(134)/Admn./CAS/IGDTUW/2018/664 dated 17.09.2021 shall remain unchanged.
